

STO Sec. 204: Fines Doubled in Road Construction and School Zones

(a) Fines listed in the schedule of fines, as established by the Municipal Court Judge, shall be doubled if a person is convicted of a ordinance traffic infraction, which is defined as moving violation in accordance with rules and regulations adopted pursuant to K.S.A. 8-249, and amendments thereto, committed within any road construction zone.

(b) Fines listed in the schedule of fines, as established by the Municipal Court Judge relating to exceeding the maximum speed limit, shall be doubled if a person is convicted of exceeding the maximum speed limit in a school zone authorized under subsection (a)(4) of K.S.A. 8-1560, and amendments thereto. (K.S.A.Supp. 8-2118)

- A Bench Warrant fee of \$20 will be assessed per warrant.
